The minor touch-up redecoration in the toilets and in the Main Hall is finished and is looking good. The boxing in of the new pipework in the kitchen is complete and after a full redecoration of that room we will need to undertake a full deep clean of the kitchen, its cupboards and all their contents ready for the reopening of the Luncheon Club once we have all been vaccinated.

This leaves the Library where we hope to be able to store not only a wide range of books and jigsaws, but all the historical records donated by Ian Thompson. Peter McKenzie, with his expertise as an archivist, is currently looking through these and will advise on appropriate storage and display of this material.

LONGHIRST VILLAGE SHOW



Although none of us suspected that we might be saying the same thing this year..... in light of the Covid-19 pandemic and associated restrictions, the very sad decision has been made not to go ahead with Longhirst Village Show for the second year running.

Profit from the annual Show is spent supporting the Village in many ways, for example buying new tables and crockery for the Village Hall, supporting the Open Gardens event and contributing to other Village groups. Although a Village Show did not go ahead last year it was decided to donate £505 to the Longhirst Parish Association, £200 of which was put towards the purchase of a new gazebo for the Village and £305 to buy a new projector screen for the Village Hall.

Should restrictions ease later in the year, it is hoped that a small group will get together with the aim of organising some form of Village event so that we can all meet up again as in the good old days!

In the meantime, let's hope that a good number of residents in the Parish are able to be vaccinated in the next few months to provide protection against this horrendous virus.

PARISH COUNCIL REPORT



At the meeting held on 7th January Councillors thanked County Councillor David Towns for paying for the **two new flashing speed warning signs** from his NCC budget.

The southern one is working well but it has been agreed with NCC that the northern one is incorrectly sited and needs to be moved away from the shade of the nearby tree (which will affect the solar panel). This installation completes the County Council speed reduction scheme for Longhirst which has been warmly welcomed.

Councillor Towns referred to the **flooding of the Ashington Road** and was pleased that Advance Northumberland and NCC Highways had met on site to agree necessary improvements. Glen Fahy and Peter Coates attended the meeting and reported that immediate ditch clearance work would be carried out, major sources of inflow investigated and hopefully the road raised through the bottom of the dip.

Councillor Towns advised any residents requiring **support during this latest Covid-19 lockdown** to contact NCC Communities Together or the Morpeth Matters Facebook group. Any parents whose children need **computer equipment** for home study should contact their local school in the first instance. Cllr. Towns believes that schools should have an adequate supply of equipment, but if anyone has a problem they can contact him direct. (Full contact details were included in the recent e-supplement).

On behalf of **Longhirst Hall** residents Andy Robson reported that one of the two new dwellings in the field north of Dairy Lane has been sold. The construction of the new footpath from Micklewood Close to allow pedestrian access into the Village might have to wait until the development work is completed. The developer has, however, promised to repair the damaged fencing mentioned at the last meeting.

Jon Mills from **Micklewood** said that he was pleased with the new speed warning signs in Longhirst and that the new estate management arrangements were not yet finalised as there are outstanding legal issues to resolve.

The **Colliery** Residents Association had indicated that they were pleased with the new road sign and requested a new dog waste bin. This was approved.

Others matters in brief:

The information given to the Parish Council that a property at the north end of the Village was a holiday let had proved to be incorrect. It is being renovated for full time occupation. The Parish Association has subsequently offered **residents north of No.17 the use of the car parking area at the Village Hall** until the Hall comes back into normal use. It is hoped that residents will take advantage of this to minimise problems with through traffic on the main road (details in the last e-supplement).

Jon Mills is taking an active interest in **Public Rights of Way** and agreed to take a lead on PROW matters on behalf of the Council. He is happy to hear from anyone with a knowledge of walking routes around the Parish.

There remains concern over housing developments underway at the **Station Cottages**. The Clerk will once more contact NCC Planning and enquire about recent planning applications and any enforcement action that is being taken.

Domino's Field - NCC have rejected the planning application for 10 new bungalows on the site. This decision was very warmly welcomed.

NCC Planners have admitted to the Parish Council that they failed to include a condition denying access for **construction vehicles up Dairy Lane**. Their Enforcement Officer has, however, contacted the developers and "strongly requested" that they only access the field on the north side through the hole in the Longhirst Hall wall.

The **shopping service** provided to some residents during the Covid-19 crisis is still available (details in the last e-supplement). Many thanks go to Dianne Milmore and Fiona Smith for doing this.

Having reviewed the current budget the Council agreed to increase **next financial year's precept** by the level of inflation from £7000 to £7200.

The quarterly **liaison meeting with North East Grains** was taking place on 15th January (see report below).

Concern was expressed over the **condition of the road to Linton from the centre of the Village**. The Clerk would contact NCC Highways.

The Red Row Garden Hut has provided Lawrence Carey with many of the materials for the maintenance of the planters in the middle of the Village and a letter of appreciation would be sent to them by the Parish Council. (See article on page 5)

The **next meeting** will be held using Zoom at **6.30pm on Thursday 4th March**. All residents are invited to take part and those wishing to do so should contact the Clerk, Helyn Douglas (a) for further information.

NORTH EAST GRAINS LIAISON MEETING

Catherine Farrell, Chris Marr and myself (from the Parish Council) and County Councillor David Towns met Matthew Curry (the Managing Director of North East Grains) for the quarterly liaison meeting on 15th January.

Matthew explained that NEG still have no immediate plans to proceed with the installation of an anaerobic digester at the plant but may go ahead with the archaeological study that is a requirement of the planning permission in the near future.

NEG have erected a new sign at the exit from the plant (positioned at drivers' eye level) instructing all grain lorries to turn right (away from the Village). The Company has also written to all hauliers explaining the return routing arrangements.

The Parish representatives reported that the general view from residents seems to be that the proportion of large trucks returning through the centre of Longhirst has reduced.

The next meeting is scheduled for mid-April.

RED ROW GARDEN HUT

For the past few years I've been buying compost and plants from the Red Row Garden Hut CIC (Community Interest Company). They operate a shop in Red Row, staffed entirely by volunteers, where they heavily discount general horticultural products (plants, seeds, compost, flowers etc.). They also supply a wide range of pet and bird foods.

Any surplus profit they make is used to support local charitable and community projects. They have supplied me with the annual plug plants used at the War Memorial at cost price and this year they have supplied all the compost free of charge and have delivered it on a regular basis.

I did not ask for this support; they simply refused to accept payment!
